SUBJECT: -Extension of General Affiliation up to Senior Secondary Level .

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

Sl. No.	The school is directed to ensure that :
1	The IC video is not available in the link (http://youtu.be/vO-rhAh0Ask) provided by the school as shared by the RC members.
2	The school is in a palace. The school campus is not properly maintained. The school has not developed and maintained the campus, playground, toilets, labs, library sports and CWSN facilities. The school does not have proper ramp to enter into the school campus and to various classrooms/activity rooms. There are multiple building blocks and the entries are through the stairs. As reported by RC, the school runs in the old building which is not constructed as per the CBSE, State Govt. Education Department norms. The class rooms are not as per the CBSE norms. All the labs also not as per the rules.
3	As per IC report, the school has 20 classrooms and most of the classrooms are of less than 400 sq ft. However as per data filled by the school, the school is running 25 sections upto XII out of which one sections each from class I to VIII and abruptly the number is increased in class IX (6 sections in class IX).
4	The school has shown the CWSN toilets outside the main building. The approach road is not developed for wheelchair/walker bound students. The regular cubicles are converted into CWSN toilets which are too small and narrow and there is no room for a wheelchair/walker to navigate. These are seen temporary arrangement, signage is temporary. No grab bars are there.
5	The washrooms are seen filthy/ unhygienic.
6	The school has not shown Maths Physics and Biology lab.
7	The school has covered a corridor to make it chemistry lab (ref RC video 1:10:24). The lab is seen temporary arrangement, some articles/chemicals/specimen are placed on the tables and does not have permanent fixtures/ demonstration tables/workstations which is not appropriate for conducting of practical. There is no exhaust fan, no valid fire extinguisher and emergency exit. This is not at all a lab as per SoP issued by the Board.

8	The school has shown two library one for junior classes and one for senior classes both are of 360 sq ft (Ref RC video 1:01:48). A single library size shall be 1200 sq ft as per CBSE norms. The reading space for students and staff in library is poorly inadequate.
9	The playground is underdeveloped and there is a small room for indoor sports. Only one chess and one carom board is seen as indoor sports facilities.
10	As reported by RC, the school has appointed the special educator but without following the CBSE appointment norms. The school does not appoint a Counsellor.
11	The EPF facility is not extended to all staff of the school.
12	The documents shown to review committee has not been uploaded by the school. Reupload is shown pending at school.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
